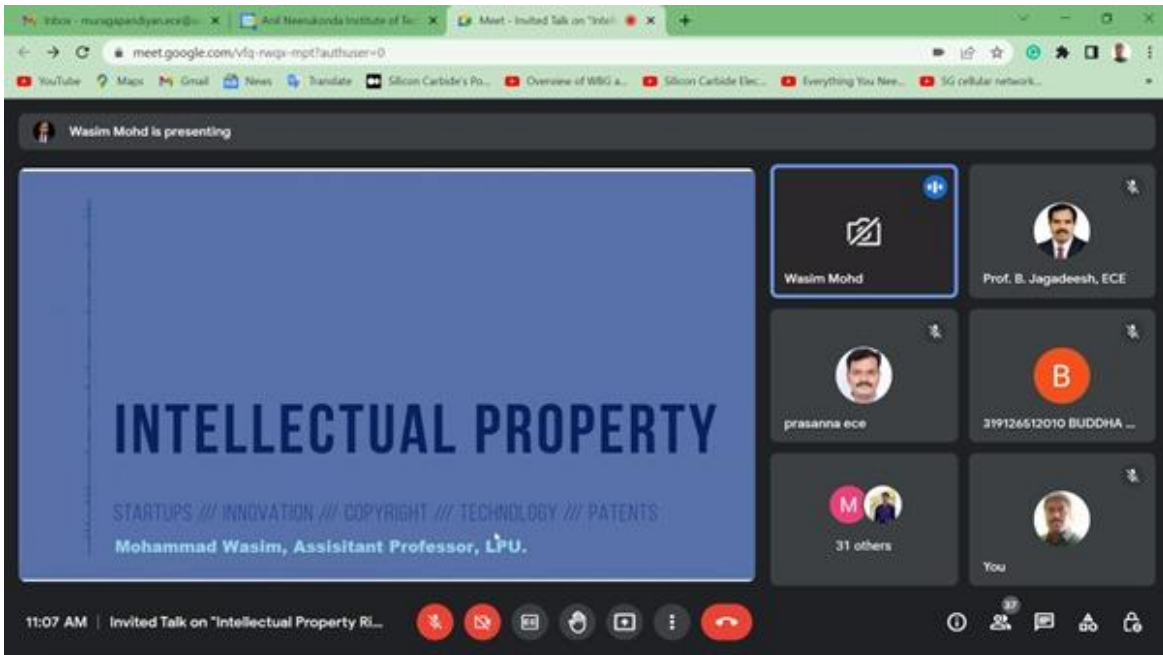


Figure 1. Mr.MOHAMMED WASIM giving brief introduction about IPR.

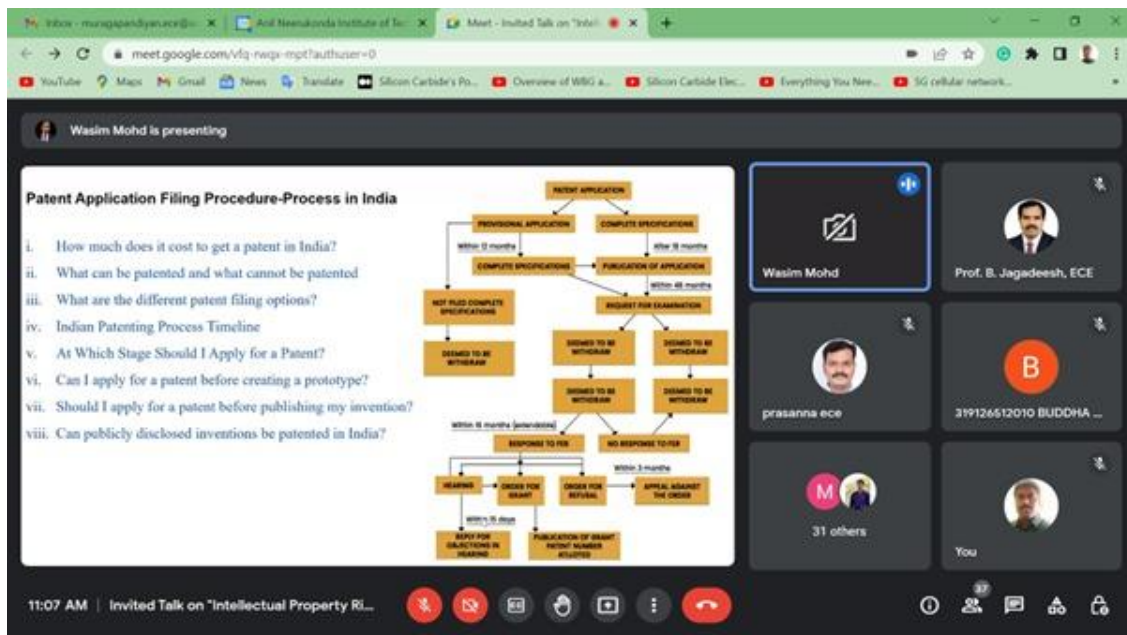


Figure 2 Mr.MOHAMMED WASIM briefing about Patent application filing procedure.

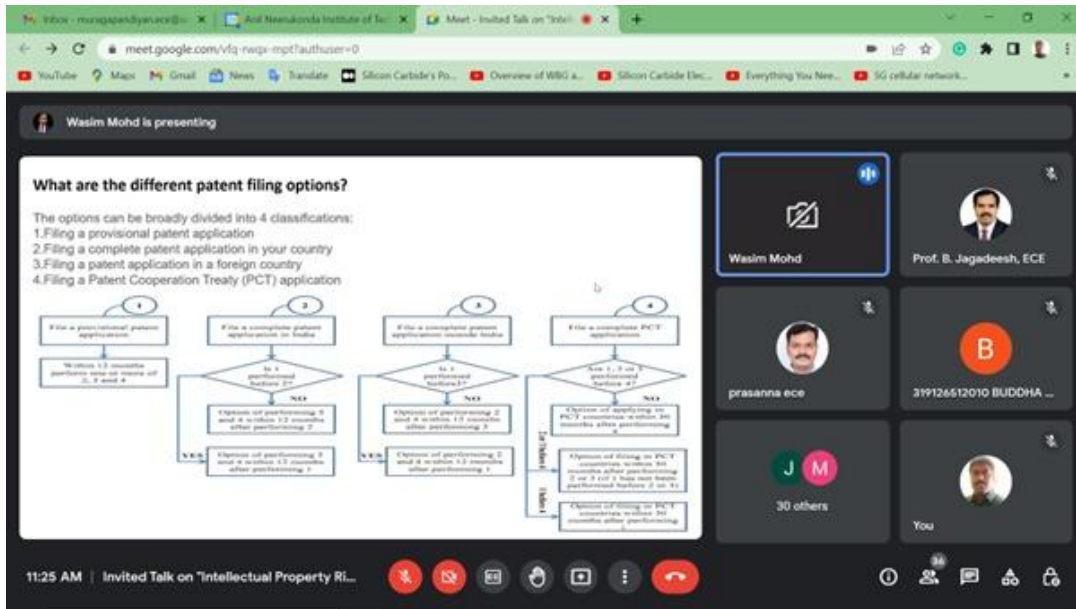


Figure 3. Mr.MOHAMMED WASIM briefing about different Patent filing option.

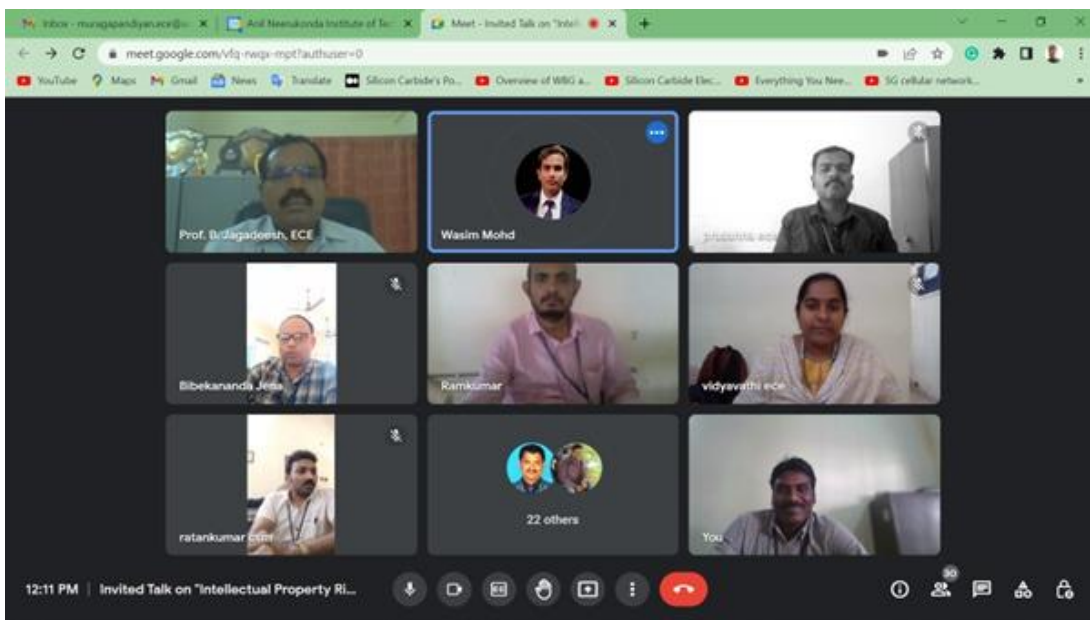


Figure 4 Mr.MOHAMMED WASIM addressing the audience queries.
